



New Covid Policies and Procedures

1.	Each member must scan in using their card (couple/friends each must have their own access card).	
2.	Please <u>review and abide to the Covid-19 pre-screening questions</u> posted at front door each entry. If you are not well please stay home and/or get a COVID-19 test.	
3.	In accordance with our local by-law personal masks/shields will be mandatory in all common areas in the Gym (ie. entering the Gym, locker rooms etc.) but will not be required (but recommended) during your workout.	
4.	Try to stay 6 feet away from other members and staff.	
5.	Lockers are available but try to maintain social distancing. <u>Showers are closed.</u> Sanitizing station located near lockers.	
6.	Stay to the right going up and down the stairs to maintain social distancing.	
7.	Bring your own water bottle preferably filled. Bottle refill only available (GOF).	
8.	Wipe down equipment using antibacterial wipes. Each can be used up to 4x.	
9.	<u>Disinfect personal items bringing into the Gym</u> ie. Water bottle, gym bag, phone, earphones, gloves etc Cover cuts, blisters and open wounds.	
10.	Members cannot let any non-member into the Gym. ALL GUESTS must schedule an app't with the Club Manager and complete a <u>GUEST COVID-19 QUESTIONNAIRE</u> .
